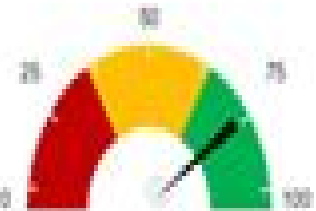

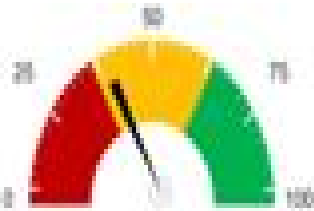

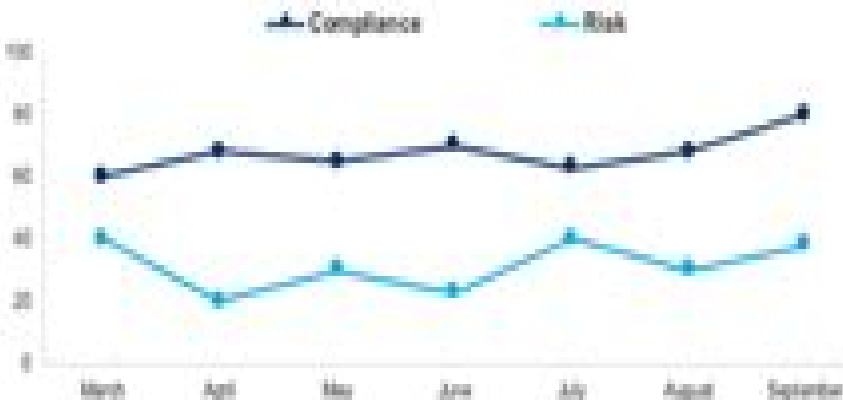
### Overall Compliance Ratings



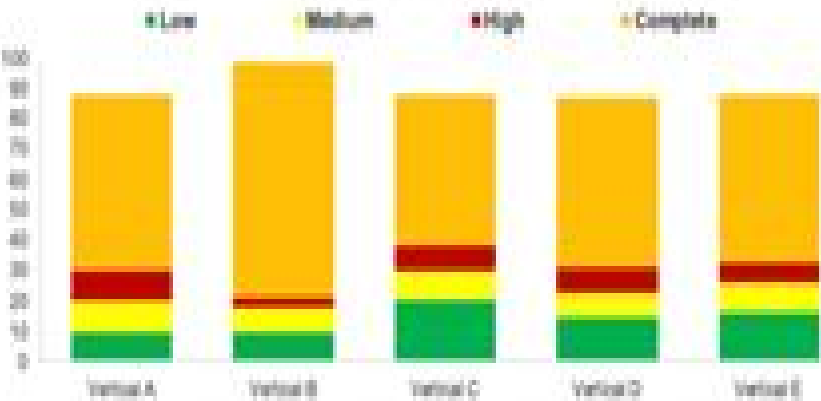
### Overall Risk Ratings
