

A contract is a legally enforceable agreement.

Promise + Consideration = K

Promise + Detrimental Reliance = K.

PROMISE

A promise is the **manifestation of intent** to act or refrain from acting in a specified way

A promise or performance must offer some kegal detriment, i.e. something of value or some form of freedom

CONSIDERATION

To constitute consideration, a performance or promise must be **bargained for**, i.e. **sought** in **exchange** for another performance or a return promise

Each party has the duty to bargain in **good** faith

DETRIMENTAL RELIANCE

In some instances, detrimental reliance acts in place of consideration.

UNENFORCEABLE

Conditional & Illusory Promises

An agreement that depends on the wish, will, or pleasure of one of the parties will not be enforced.

No Commitment

One party cannot convert what both parties knew to be a joke into a serious transaction simply by claiming it to be so.

There must be a meeting of the minds.

DISCRETIONARY

Vague & Indefinite Terms

Six Ways of Interpreting a Term:
