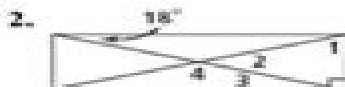


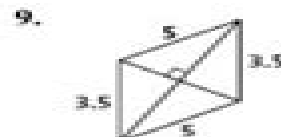

$HJK$  is a rectangle. Find the value of  $x$  and the length of each diagonal.

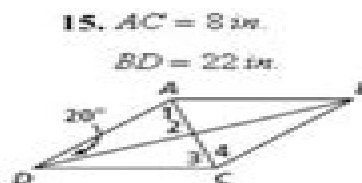
