

RELOADING SAFETY RULES

Reloading is an enjoyable and rewarding hobby that is easily conducted with safety. But, like many other human activities, mistakes or negligence can make reloading hazardous.

The source of reloading safety is proper handling and storage of primers and powder. By observing the following rules, the chance of loading accidents becomes extremely remote.

Keep primers and powder beyond the reach of children and away from heat and open flames. Do not smoke when reloading.

Keep an open powder that needed to an open container. Immediately store unused powder in its original factory container.

Don't use any powder unless its identity is positively known. Keep all used powder and those of uncertain or unknown identity.

Do not store primers in bulk. To do so is to create a hazard! Bulk primers will soon detonate. Do not use primers when their identity is lost. Safety depends on unknown types of primers.
