OVERVIEW OF A CRIMINAL PROCEEDING

PROBABLE CAUSE FOR ARREST

- Prior to any arrest, police must have probable cause to believe that a crime has been committed and the suspect being streeted has committed that crime.

- PRELIMINARY HEARING

- Live witnesses, prosecution, and defendant with counsel are present
- Maginitude determines whether there is probable cause sufficient to believe the suspect committed the crime and to bind the case over for trial

- INFORDICTION OR INDICTMENT

1. Indoorseller

- A. After a finding of probable cause at the preliminary hazing, prosecutor propers and files information alleging all the charges with the trial court, which replaces the criminal complaint
- If there is no finding of probable cause at the preliminary hearing, the criminal complaint is discussed and no information in filed.

2. Indictment

A. A greed jury hearing is an ex parte presentation of evidence by the presecutor to the grand pursus, often without definishent or defining commel present.

- B. If the grand jury decides there is sufficient probable cause to support the charges, the presecutor prepares and files an indictment with the trial count.
- C. A defendant charged with a federal felory may only be tried pursuant to a grand jury indictment.

ARRANGSMENT

- The defendant pleads guilty, no contest (noise contendent), or not guilty to the information or indictment
