Sakoon had to buy the vehicles from another supplier at an extra cost of Rs. 2 million for supplying these to QL. Sakoon also had to pay compensation of Rs. 0.6 million to QL due to delay in supply.

Under the provisions of the Contract Act, 1872 analyse the above situation and comment whether Sakoon is entitled to receive any compensation from DL. (5)
