2. **Voidable Agreement:** Definition:** A voidable agreement is a valid contract, but one party has the option to void or enforce it.**Example:** A contract with a minor, who has the option to void the contract upon reaching the age of majority.

3. **Enforceable Agreement:** Definition:** An enforceable agreement is a valid contract that can be enforced in a court of law.**Example:** A typical business contract where both parties have fulfilled their obligations, and the agreement is legally binding.

c) **Revocation of an Offer:** An offer can be revoked under certain circumstances, and the revocation becomes effective when it is communicated to the offeree. Here are some broad explanations:

****By the Offeror:**** The offeror (the person making the offer) can revoke the offer at any time before the offeree (the person receiving the offer) accepts it. The revocation is typically communicated directly to the offeree.

****Before Acceptance:**** Once the offeree has accepted the offer, the contract is formed, and the offeror cannot revoke the offer. However, if the offeree hasn't accepted, the offeror can freely revoke the offer.

****Indirect Revocation:**** Sometimes, an offer can be indirectly revoked if the offeror takes actions inconsistent with the intention to make an offer. For example, selling the subject matter of the offer to someone else may be considered an indirect revocation.

****Lapse of Time:**** If a specified time period is mentioned in the offer for acceptance, the offer may be automatically revoked if the offeree doesn't accept within that time frame.

It's important to note that the rules regarding the revocation of an offer can vary depending on jurisdiction and the specific terms of the offer.
