PLEA AGREEMENT

23 1. The indictment in this case charges the defendant with violation of 21 U.S.C. § 841(a)(1) –
24 possession with intent to distribute (Count 1), 18 U.S.C. § 1708 - possession of stolen U.S. Mail (Count
25 2), 18 U.S.C. § 1703 - delay and destruction of U.S. Mail (Count 3), and alleges forfeiture under 21
26 U.S.C. § 853(a). This document contains the complete plea agreement between the United States
27 Attorney's Office for the Northern District of California (the "government") and the defendant regarding
28 this case. This plea agreement is limited to the United States Attorney's Office for the Northern District
of California and cannot bind any other federal, state, or local prosecuting, administrative, or regulatory
authorities.

2. The Court is not a party to this plea agreement. Sentencing is a matter solely within the
discretion of the Court, and the Court may take into consideration any and all facts and circumstances
concerning the criminal activities of defendant, including activities which may not have been charged in
