The CACG Guidelines are intended to be precisely that – guidelines to facilitate best business practice and behaviour, whether of a private sector or state-owned enterprise.

These guidelines are neither mandatory nor prescriptive and have been designed as evolutionary in concept. In other words, the CACG Guidelines are seen as a “continuum”, remaining flexible and responsive to further developments in corporate governance in the global economy.

The Commonwealth, through its participation in the Global Corporate Governance Forum with the World Bank and OECD, is committed to a uniform approach on corporate governance issues internationally.

Consequently, the CACG Guidelines have been structured on a basis complementary to the OECD Principles of Corporate Governance, with
