## Transaction Monitoring

Involves record keeping and reporting practices, such as Suspicious Activity Report (SAR) filing.

## Internal Processes and Policies

Includes procedures like employee training and maintaining compliance with AML programs.

## Testing and Auditing

Consists of processes designed for ongoing monitoring and auditing to keep the risk assessment measures up to date.
