#### 8 Steps to Getting Your Chapter 13 Discharge

#### Chapter 13 Pre-Filing

Collect your financial data before preparing the bankruptcy petition, schedules, and statements. The amount of time this takes depends on how long document preparation takes.

#### File Your Bankruptcy Forms

Once the debtor certifies that everything in the forms is accurate, they sign the documents. File the case with the bankruptcy court and receive protection from the automatic stay. Within 21 days of filing, submit all requested documents to the bankruptcy trustee.

#### Begin Your Repayment Plan

The debtor must begin making payments within 30 days of filing. This will generally occur before the 341 meeting of creditors. This is the case unless the bankruptcy court orders otherwise.

#### 341 Meeting of Creditors

Around 30-40 days after filing, the first 341 meeting of creditors occurs. The filer's creditors can ask them questions under oath, which they must answer truthfully. If creditors have any objections, they must file those objections within 7 days of the first 341 meeting.

#### **Debtor Education Course**

Within 75 days of the first 341 meeting, the debtor education course must be completed. The debtor must file the certificate of completion with the court at this time.

#### **Complete All Plan Payments**

If no objections arise, the payment plan proceeds for the agreedupon duration of time. This is usually between 36 and 60 months. The debtor must complete all payments, after which the trustee will issue a Notice of Completed Plan Payments.

#### Final Report from Bankruptcy Trustee

Within 4 months of the completed plan payments, the trustee issues a final report to the court about the disbursement of payments. Any involved parties have 33 days to object to the report.

#### Get Your Chapter 13 Discharge

Once the trustee files a Notice of Intent to Enter Discharge, involved parties have 14 days to object. If no parties object, the discharge finalizes the bankruptcy case, clears any remaining dischargeable debts, and protects the debtor from further collections.
