Inefficiencies of market theories

New information not available to everyone.

Not everyone reacts the same.

Not all forecasts are accurate.

Investors psychology or greed could be irrational.

## Efficient Market Hypothesis

Stock price is the best estimate of true value.

The profit seeking with react quick and adjust for intrinsic value.

Stock price fully reflects all available information.
