- I. Chapter 31: Bankruptcy
- a. Purpose of 2005 Reform Act: require more consumers to pay as many debts as possible and prevent fraud
  - b. Bankruptcy goals:
    - i. Protect debtor by giving them a fresh start without creditors' claims
    - ii. Ensure equitable treatment of creditors who are competing for debtor's assets
  - c. Property exempted from bankruptcy (federal list):
    - i. Portion of equity in debtor's home (homestead exemption)
    - ii. Motor vehicles up to certain value
    - iii. Reasonably necessary household goods
    - iv. Pensions
    - v. Portion of unpaid but earned wages
  - d. Chapter 7: liquidation proceedings
    - i. Type
    - ii. Who can file
    - iii. General petition requirements – petition must contain:
      - 1. List of creditors and amount of debt owed to each
      - 2. Statement of debtor's financial affairs
      - 3. List of all property owned
      - 4. List of current income and expenses
      - 5. Certificate of credit counseling
      - 6. Proof of payments received from employers
      - 7. Itemized statement of monthly income
      - 8. Previous tax returns
    - iv. Means Test – abuse prevention: court may dismiss petitions for substantial abuse or failure to pay domestic support obligations (if debtor has violent or drug crime conviction, victim can file motion to dismiss) – law provides “means test” to determine eligibility
    - v. Voluntary vs. Involuntary Bankruptcy
      - 1. Voluntary: before debtor files a petition, must receive credit counseling
      - 2. Involuntary: debtor's creditors force debtor into
        - a. Requirements:
          - i. If debtor has 12 or more creditors, 3 or more creditors having unsecured claims total at least \$15,321 must join the petition
          - ii. If debtor has fewer than 12 creditors, 1 or more creditors having claim totaling \$15,325 or more may file
