

## Chapter 3: Tax Formula and Tax Determination

Components of the tax formula

Tax liability = taxable income x tax rate

- Income: All income taxable and non-taxable, "any increase in wealth"
- (Exclusions): Items congress has chosen to exclude
- Gross Income: All income unless specifically excluded
- (Deductions for AGI): Above the line of deductions
- AGI: Used to limit itemized deductions
- (Deductions from AGI): Below the line of deductions
- (Itemized/Standard Deductions): Personal expenses Congress allows
- (Charitable Contributions)
- (Personal Dependency Exemption): Suspended until 2025
- (Deduction for Qualified Business Income): Allowed until 2025, 20% of income from non-corporate business
- Taxable Income

Itemized Deductions from the following can only be taxed up to \$10,000 (if more then don't count it)

- State/local income or sales tax
- Real estate taxes
- Personal property taxes

Itemized Deductions can have floor or ceiling limitations

- Floor limitation: amount above the AGI
- Ceiling limitation: amount below the AGI
- **AGI line formula = taxable income x %**

Standard Deduction

- 5 filing statuses outlined in slides
- Income vs Ability to Pay (takes your everyday expenses into account that you need to live)
- Basic standard deduction according to filing status
- Choose the larger of itemized or standard deduction (can select each year)
- Taxpayer who is over 65 or blind qualifies for an additional standard deduction
  - o Applies to qualifying spouse but not a dependent
- Individuals not eligible for standard deduction
  - o If married filing separately and spouse itemizes, you have to itemize
  - o Non-citizens/residents
