### Taxation

#### Deferred tax

an accounting measure used to match the tax effects of transactions with their accounting treatment. It is not a tax that is levied by the government that needs to be paid, but simply an application of the accruals concept.

#### Tax expense

= current tax +/- movement in deferred tax
