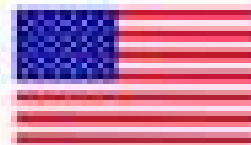




# Supreme Court Cases



Court Case	Year	Topic and/or Amendment	Vote	Description
<i>Marbury v. Madison</i>	1803	Judicial Review	4-0	William Marbury was appointed to a judge position in DC, but the new Sec. of State James Madison did not deliver the commission. The court agreed that Marbury should have the position, but did not have the authority to put Marbury in the position. In this case the court struck down an act of Congress and established the principle of judicial review.
<i>McCulloch v. Maryland</i>	1819	Federalism Supremacy Clause	7-0	Md. state banks refused to hold a federal bank the US bank in Maryland and refused to pay a tax levied by the state of Maryland. The court stated the power to tax was the power to destroy and states had no right to tax the federal government. This case upheld the Supremacy Clause.
<i>Schenck v. U.S.</i>	1919	1st Amendment Freedom of Speech	9-0	The court agreed that Schenck's freedom of speech rights can be limited if it creates a clear and present danger <sup>1</sup> . Schenck was convicted of violating the Espionage Act of 1917 for convincing 17 soldiers not to join the army in WWI.
<i>Brown v. Board of Education</i>	1954	14th Amendment Equal Protection	9-0	The Brown decision reversed Plessy v. Ferguson and struck down the 'separate but equal doctrine'. This decision desegregated schools and allowed African American children to go to the same schools as white students.
<i>Reynolds v. Sims</i>	1964	14th Amendment Equal Protection Clause	6-2	A member of TX, Charles Reynolds sued the Gov. of Alabama TX Gov. Ross Perdue to uphold the rights that have existed due to population shifts and the reapportionment of legislative seats. The court agreed and helped establish 'the one man, one vote' principle that is foundation of similar population size.
