Number of skilled workers		350
Standard monthly hours per worker		200
Standard hours per unit		3
Normal wage rate per hour	Rs.	150
Overtime wage rate per hour	Rs.	250
Variable overhead rate per hour	Rs.	120

In order to reduce the conversion cost, CL's management is evaluating the following two wage incentive plans:

**Option 1:** Introduce a piece wage system at the rate of Rs. 500 per unit. This is expected to make workers 15% more efficient.

**Option 2:** Introduce a bonus of Rs. 50 per unit if a unit is completed within 90% of the standard time. It is expected that after introduction of bonus, 70% units will be completed within 90% of the standard time.
