#### ■ AUTOSOMAL RECESSIVE DISORDERS

- *Phenylketonuria (PKU)*
  - caused by allele on chromosome 12
  - body lacks enzyme to break down phenylalanine (amino acid found in milk and other foods)
  - build up of phenylalanine in early life causes severe cognitive deficiencies, lack of normal skin pigment
  - can be tested for
  - treated with low phenylalanine diet
- *Tay-Sachs Disease*
  - caused by allele found in demographics with Jewish-ancestry from central and eastern european descent
  - causes nervous system to break down and death in first few years of life
  - no treatment
  - can be tested so parents with risk of child with tay-sachs may prefer to be childless or to adopt
- *Cystic fibrosis*
  - recessive allele on chromosome 7; missing only 3 dna bases from chromosome
  - common among those with northern european ancestry (cold weather)
  - produces thick, heavy mucus that clogs the lungs and breathing pathways... and digestive problems in children
  - mucous is so thick cilia in bronchi, bronchioles of lungs cannot move mucous---long term effects as antigens build up
