THE LAW OF CONTRACT, WHILE NOT A CODIFIED STATUTE IN INDIA, IS PRIMARILY BASED ON ENGLISH COMMON LAW PRINCIPLES AND HAS BEEN SIGNIFICANTLY INFLUENCED BY THE INDIAN CONTRACT ACT, 1872. IT OUTLINES THE ESSENTIAL ELEMENTS OF A VALID CONTRACT, INCLUDING:

- OFFER AND ACCEPTANCE: A CLEAR PROPOSAL AND ITS ACCEPTANCE.
- CONSIDERATION: SOMETHING OF VALUE EXCHANGED FOR A PROMISE.
- CAPACITY: THE LEGAL ABILITY OF PARTIES TO ENTER INTO A CONTRACT.
- FREE CONSENT: GENUINE AGREEMENT WITHOUT COERCION, UNDUE INFLUENCE, FRAUD, OR MISREPRESENTATION.
- LEGALITY: THE CONTRACT'S PURPOSE MUST BE
- * POSSIBILITY OF PERFORMANCE: THE TERMS OF THE CONTRACT MUST BE CAPABLE OF BEING PERFORMED.

THE SPECIFIC RELIEF ACT, 1963.

THIS ACT PROVIDES REMEDIES FOR ENFORCING CONTRACTUAL OBLIGATIONS. IT DEALS WITH SITUATIONS WHERE MERE MONETARY COMPENSATION IS INADEQUATE AND SPECIFIC PERFORMANCE OF THE CONTRACT IS REQUIRED.

KEY PROVISIONS INCLUDE:

- SPECIFIC PERFORMANCE: THE COURT ORDERS A PARTY TO PERFORM THEIR OBLIGATIONS UNDER THE CONTRACT.
- INJUNCTIONS: THE COURT PROHIBITS A PARTY FROM DOING SOMETHING (PROHIBITORY INJUNCTION) OR COMPELS THEM TO DO SOMETHING (MANDATORY INJUNCTION).
- RECOVERY OF POSSESSION: THE COURT ORDERS THE RETURN OF SPECIFIC PROPERTY.
- RECTIFICATION AND CANCELLATION OF INSTRUMENTS: THE COURT CAN CORRECT MISTAKES IN A CONTRACT OR CANCEL IT UNDER CERTAIN CIRCUMSTANCES.
