**Review:**

1. **Electric field** is defined as the aura about the space surrounding a charged object that exerts an electrical influence upon other charged objects in that space. The **direction of the electric field vector** is defined as the direction that a positive test charge would be accelerated. **Potential energy** is the energy stored in an object due to the position of that object.

2. Two diagrams are shown at the right.

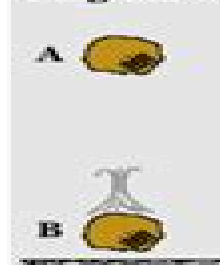
In diagram A, a mass is held at an elevated position. When let go of, the mass falls from point A to point B.

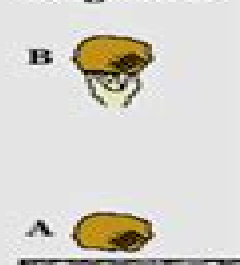

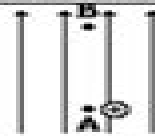
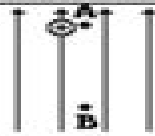
